I. Opening

- a) Jo Morrissey reviewed the agenda and performed introductions.

II. Governance

- a) The group reviewed 21 Reasons Coalition Guidelines and Practices, including suggested edits for the coming year. The edited guidelines were approved unanimously.

- b) The group approved new leadership for the upcoming year. Sue Steele was nominated for the position of Coalition Chair and was approved unanimously. Ray Ruby was nominated for the position of Coalition Vice-Chair and was also approved unanimously.

III. Operations

- a) Jo updated the group on several recent developments:
- New principals at Portland High School and Riverton Elementary.
 - The new PHS principal was a big supporter of the DFC Coalition in prior community (Derry, NH).
 - Possibility of working with her and Portland High School parents (table talks, for example).
 - Upcoming meeting with Dr. Morse.
 - We're planning to propose Table Talks (supported or sponsored) for parents and staff training to improve modeling and messaging to students.
 - Sue suggested that we work towards mandatory training for all coaches, health/PE teachers, and administrators/assistant principals, and emphasized the importance of working with the middle schools.
 - Looking ahead, Chalk It Up (perhaps with state-wide partners) and a legislative breakfast will be coming up this fall.
